These courts cover Fulton County, the most populous county in Georgia and the county seat of state capital Atlanta. Fulton County serves a population of over 1 million citizens, including much of Atlanta, and is an important court for civil cases involving contracts, torts, property, and other civil matters. 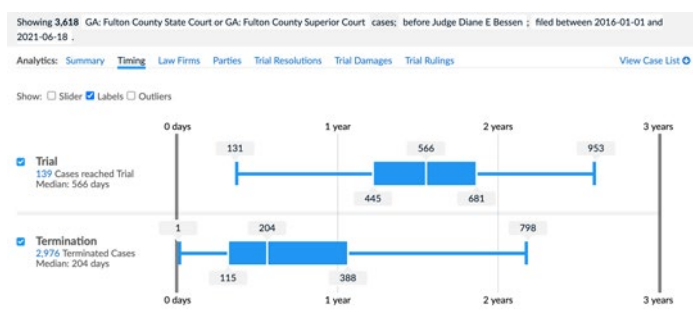

Trial Damages – General Damages (Judgment on the Merits), General Damages (Jury Verdict), Attorneys' Fees / Costs

Trial Rulings – Bench Trial, Jury Verdict, Consent Judgment, Default Judgment, Other Judgment
